Eric noted he will begin by sending out a member survey to see what topics would be of interest and will start putting together a speaker list. Having a Chapter Program Chair will be a significant help in getting informative and timely presentations on the calendar for the coming year and hopefully help increase participation. The Board is incredibly pleased and excited to have Eric step into this new role.

Past Meeting and Events

<u>Tracy Hazel's presentation on MIOSHA visits and emphasis programs for 2025</u>: This presentation took place on April 4, with approximately 8 attendees. The presentation was good, and the smaller group allowed for Tracy to interact with attendees more and answer questions more tailored to the group.

<u>Mid-Michigan Conference Booth:</u> The West Michigan Chapter brought handout materials for the booth. We have a sample set of the information now. The booth was in a good location and had a fairly suitable number of visitors. Most of the visitors were from West Michigan and Greater Detroit chapters. We have a list of names and emails of nonmembers that were interested in joining and being entered into a drawing for a free membership.
